Dear members and friends of the European Land and Soil Alliance,

On 29 April 2021, the Federal Constitutional Court ruled that the government's Climate Protection Act was in part unconstitutional, thereby strengthening climate protection in Germany. In doing so, the Court referred to Article 20 of the Basic Law, whereby the state has the responsibility to protect the natural resources for future generations. This also turns the spotlight on soil, as soil protection is climate protection.

Soils are carbon repositories and thus form an indispensable part of the climate change framework. Adaptation policies must be aimed at protecting the soil from erosion, loss of humus and other climate-related risks.

This topic is not new, and climate protection activists have long been highlighting the importance of soil protection for the climate.

Climate change and soils: Soil and climate are closely related and are mutually dependent. "Klimanavigator" (Climate Navigator) – an initiative of numerous German climate research institutions and networks – provides a good overview of the various aspects on its internet portal.

EJP Soil – new EU research initiative: The management of agricultural soils plays a key role in the discussion on climate change. With this in mind, the EU Commission and 24 member states have launched the European Joint Programme "EJP SOIL". An important part of the programme is to initiate transeuropean research projects that provide new insights into options for climate-friendly, sustainable soil management.

Soil and climate. Online series of events: The Soil Alliance and the Climate Alliance share a 20-year common history. There is now a joint series of events on the multi-faceted association between soil and climate. This started on 28 April 2021 with a webinar entitled "Sponge city –

dealing with too much or too little water". The webinar is also available online. Follow-up dates are still to be announced.

Guidance document "CO₂ certificates for carbon sequestration in soils: methods, management practices and limitations": Agricultural soils have a great potential for carbon sequestration due to the build-up of soil organic matter (humus). The study provides recommendations for recording and evaluating the carbon content of soil.

CarboCheck: This project includes the development of an app that can be used to estimate the current humus content using a photograph of the soil and the location coordinates. Based on this value and additional soil, climate and management information, the development of the soil humus and soil carbon content over time can be predicted.

European tender "EJP SOIL": Funding will be provided for up to five collaborative projects that will research findings and technologies with the aim of establishing climate-smart and sustainable soil management. Interested parties must register by 25 June 2021. Proposals must be received by 7 September 2021.

Guidelines for "Soil protection on line construction sites": The energy revolution has significantly increased the focus on the laying of underground cables. In its guidelines, the State of Schleswig-Holstein provides detailed practical application guidelines for the different phases of a line construction project, from planning, through pedological site support during construction right up to restoration of soil functions.

North Rhine-Westphalia offers a soil protection prize. The North Rhine-Westphalia Ministry for Environment, Agriculture, Nature and Consumer Protection and the Association for land recycling and remediation of contaminated sites is once again offering the North Rhine-Westphalia soil protection prize worth 10,000 euros as part of the "Land and soil alliance NRW".

Moor protection equals climate protection: Twenty-three environmental organisations have requested the German federal government to adopt an ambitious moor protection strategy.

Soil moisture viewer: With this viewer, the German weather service is making available a tool that displays information on soil moisture and other water balance values. This information enables users to monitor the water supply in the soil. In this way, it is possible to make an initial analysis of a situation, e.g. in times of high rainfall, dryness and drought.
